Snapshot: Member Commentary



"There has definitely been a difference in customer bookings at Level I. However we can't be certain at the moment we're only still meeting at about 35-40% of what we need to be doing. Reality will only set in when wage subsidies have dried up."

"At this rate of income & without the borders open we, and many others in our situation, will run out of (cash flow) funds by around October this year when the mortgage holiday is over."

"I think that hospo businesses in regional tourism areas who have relied on international tourists will need the wage subsidy to continue until at least late November/December."

Common pain point

Rent and lease challenges remain with no clear pathway for relief.

Future Considerations

- Lead contact point for sector and Government? MBIE is reconsidering its role as lead agency for hospitality
- Ongoing viability past extended wage subsidy and no foreseeable plan for international tourism
- Trans-Tasman or Pacific Bubble travel
- Focus of marketing campaigns around buying local, to reinforce how small local business livelihoods now rely on this.
