Snapshot: Member Commentary



"While people have returned to work - the new work from home culture emerging is having a significant negative impact on CBD cafes - especially at the beginning and end of the weeks."

"Trying to survive - whilst we are covering current costs it is not giving us enough to pay back all the money lost during levels 2,3 & 4 especially as could not get wage subsidy extension and are on full rental."

"New lease agreement (last right of renewal finished April 21, during lockdown) – Landlord wants 10% increase, we want a rent reduction to reflect the market." "Immigration NZ's current position of employing New Zealanders is difficult. Many chefs have left the country and not been replaced by returning kiwis. We have a serious crisis looming this summer if [there is not flexibility in the system]."
